A safety audit is a structured process whereby information is collected relating to the efficiency, effectiveness, and reliability of a company's total health and safety management system.

Safety audits serve two broad purposes:

- 1. They are routinely conducted in order to determine whether the company is in compliance with safety legislation. These can be performed by representatives of a regulatory body or by the company itself.
- 2. They are used to identify weaknesses in their safety programs and processes. These audits are then used as a guide for designing safety plans or to identify corrective actions that should be undertaken
